The ends of adjacent Wattles should be tightly abutted so that no opening exists for water or sediment to pass through. Alternately, Wattles may be lapped, 15.24 cm (6") minimum to prevent sediment passing through the field joint.
- B. Wooden stakes should be used to fasten the Wattles to the soil. When conditions warrant, a straight metal bar can be used to drive a "pilot hole through the Wattle and into the soil.

The netting shall be gathered and disposed of in regular means as it is non-hazardous, inert material.

Trenches, depressions or any other ground disturbances caused by the removal of the temporary straw wattles shall be backfilled and repaired with the excess sediment captured by the wattle, prior to spreading the straw or other final erosion control protection.

.8 WATTLES IN A PERMENANT EROSION CONTROL APPLICATION

A. Leave wattles as installed to photodegrade or biodegrade over time as native and applied vegetation ultimately stabilize the repaired site.
